- 3. RENTAL INSURANCE: Tenant agrees to purchase and maintain a rental insurance policy that covers the Pet(s) who are living on the Premises as a condition of this agreement.
- 4. PET CONTROL: Tenant shall keep the Pet as a companion animal in accordance with all applicable laws and ordinances, including licensing the Pet, keeping current all applicable vaccinations, and leashing the Pet when on public property. Tenant's pet shall be spayed or neutered to prevent heat cycles and breeding, to inhibit marking indoors and to support appropriate behaviors. Tenant shall promptly remove and properly dispose of all pet waste, and shall not curb the Pet on the shrubbery, flowers, or small trees. Tenant shall not permit the Pet to dig in the yard, 'fence fight' with neighboring dogs, hunt wildlife or escape the property and roam. Tenant shall not permit the Pet to bark, howl, or otherwise emit noises in such a level, frequency, or time as to disturb others. Pet shall not be 'protection trained' or 'bite trained' or encouraged to serve as a guard dog. Tenant shall not keep the Pet on the Premises if the Pet becomes vicious or threatening, bites or attacks any person, or otherwise becomes a nuisance. Tenant shall not leave the pet on the Premises unattended for any period in excess of hours. Tenant shall reinforce excellent house manners and provide proper containment (dog crates, kennels, baby gates, etc) as necessary to prevent damage and soiling in the house. Tenant shall provide adequate care, exercise, food, and shelter for the Pet and not abuse the Pet in any way.

- **5. CONDITION OF PREMISES**: Tenant shall be responsible for all damage caused by the Pet to the Premises, including all repairs and replacements considered appropriate by Owner or Agent. Upon termination of the Lease or removal of the Pet from the Premises, whichever occurs first, Tenant shall have the Premise carpets professionally cleaned and deodorized and, if Owner deems necessary, have the Premises professionally exterminated at Tenant's cost through companies approved by Agent. Tenant shall provide Agent with copies of paid receipts as proof of the extermination and cleaning. Tenant shall remain liable for dormant infestation and latent pet odor (including extermination costs and carpet replacement and/or floor refinishing if necessary) for 30 days after the Pet is removed from the Premises and the required extermination and cleaning are complete.
- **6 ADDITIONAL ENTRY RIGHTS**: In addition to Owner's rights under the Lease, if Owner receives any complaint regarding the Pet or otherwise has reason to believe that a violation regarding the Pet has occurred, Owner and/or Agent may enter the Premises to investigate the possible violation. Owner and Agent will only enter the Premises under this provision on reasonable notice and at reasonable time unless the circumstances require otherwise, such as in the event of an emergency, Tenant's absence from the Premises, or Tenant's attempted evasion of the requirements of the Lease or this Addendum.
- **7. REMOVAL OF PET**: In an emergency, or if the Pet becomes vicious, appears severely ill, or otherwise behaves in a manner that Owner or Agent believes poses an immediate threat to the health and safety of the Pet or others, Owner and Agent may enter the Premises and remove the Pet and take any other action which Owner or Agent considers appropriate, including placing the Pet in shelter or other similar facility. In such an event, Tenant shall be responsible for all costs incurred. Owner shall only act under this paragraph if Tenant has failed to take corrective action within a reasonable time after being requested to do so or if Tenant is not available.
- **8. INTERPRETATION:** This Addendum supplements the terms and conditions of the Lease. If any provision of this Addendum conflicts with any provision of the Lease, this Addendum shall control. All rights and remedies of Landlord are cumulative. Any default under this Addendum shall constitute a default under the Lease.
